

**GARRISON ISD BOARD MINUTES**

**1. Call to Order and Establish Quorum –**

President Bart Reneau called the meeting to order at 7:00 P.M. A quorum was present and due notice had been mailed and published. Bart Reneau, Glenn Ramsey, Billy Cooper, Russell O'Dell, Mike Hammer, Lane Barton, and Kerry Beard were present.

**2. Invocation –**

Michael Hammer led in prayer.

**3. Comments from the Public –**

There were no comments from the public.

**4. Receive and Approve Minutes of January 21, 2010**

The minutes of the January 21, 2010 meeting were received.

**5. Bills and Accounts for January 2010**

**6. Principal Reports –**

Ms. McKnight reported an elementary school enrollment of 327 with an ADA of 97.8%.

The TAK's field writing test will be given February 25<sup>th</sup> and the actual TAKS writing test will be given March 3<sup>rd</sup>. The Elementary will host their open house March 11<sup>th</sup> beginning at 5:30 p.m.

Middle school had an enrollment of 159 with an ADA of 96.4%. Mrs. McKnight gave the middle school report in the absence of Allan Metcalf as he was in Alto at the Jr. High Track Meet.

Garrison Middle School had 18 sixth grade band students to participate in young bands solo and ensemble contest in Elysian Fields on February 6<sup>th</sup>. Each solo and ensemble received a first division superior medal. Junior High basketball has come to an end and track has started.

Garrison Middle School students are raising money for the American Heart Association and so far have raised over \$1500.00. Open House for the Middle School will be March 11<sup>th</sup> at 6:00 p.m. and March 12<sup>th</sup> all parents and grandparents are invited to eat lunch with their student.

Mr. Bernard, the high school, had an enrollment of 196 and an ADA of 95.8%.

Mr. Bernard reported that softball is off to a good start. Cheerleader tryouts will be March 10<sup>th</sup>. Spring Break will be the week of March 15<sup>th</sup>.

Total enrollment for the District was 682.

**7. Budget Report –**

Mr. Webb and Mrs. Stanaland presented the monthly budget report to the board for their review. It was reported that the budget looked good.

**8. Investment Report –**

Mrs. Stanaland explained the quarterly investment report.

**9. Facility Update**

Mr. Webb provided the board with an update on the proposed facilities. He reported that Terracon was out last week taking site pictures and they do not foresee any major problems. Goodwin-Lasiter is in the process of finishing plans. The plans were reviewed last week by the band director, elementary principal, Coach Phillips and Coach Williams, Mr. Comer and Mr. Webb. The plans are still on schedule and should start on the project in mid to late May.
